Dear Mr. Bose:

Thank you for the opportunity to express support for the Kansas City Riverfront Railroad Crossing Elimination Study grant application. We enthusiastically endorse this project to improve safety and create better connections between the Berkley Riverfront and adjacent neighborhoods by eliminating the at-grade rail crossings on Lydia Avenue.

Kansas City and Port KC have made enormous strides in improving the riverfront and creating a regional amenity along the Missouri River. However, the railroad lines to the south create a barrier between the Riverfront and adjacent neighborhoods. Today, Lydia Avenue is the only connection between the Riverfront and the neighborhoods to the east and south and requires crossing four railroad lines at-grade.

Continuing development along the Riverfront, particularly the construction of the new KC Current stadium, will continue to attract more residents, workers, and visitors to the area. Removing the at-grade rail crossings at Lydia Avenue will provide a safer connection between the Riverfront and the Kansas City community.

Improving connections by eliminating the at-grade crossings will also advance economic development of the area. Safer connections along Lydia Avenue will encourage additional development opportunities in the area, connect neighborhood residents to jobs, and support the significant investments along the Riverfront.

We are excited to see the positive impacts this study will have on our community and look forward for the chance to lend further support in its implementation.
